## 1. DEFINITIONS AND RULES OF CONSTRUCTION

### 1.1 Definitions

“**Distribution**” is defined as a publication being:

- sent by mail, or
- sent by fax, or
- notice sent by e-mail and publication placed on the FITA website, as requested by the Member Association.

“FITA Family” is defined as:

- FITA members and their officers;
- FITA officers, including Council, Honorary officers, Board of Justice and Ethics members, Permanent and AdHoc Committees members;
- FITA Judges;
- FITA Staff, including any person remunerated by FITA;
- Any person accredited to a FITA International Event;
- The candidate cities for the FITA International Events;
- The Organising Committees of FITA International Events.

“International Events” are defined as:

- Competition for World and Continental titles;
- Competition for Olympic and Paralympic titles;
- Competition for World Ranking;
- Olympic and Paralympic Qualification Events (Continental Qualifying Tournaments);
- Archery events of Major Event Organisations;
- And any other Event for which FITA is the ruling body or appoints technical officials;

“**Publication**” is defined as printed matter or documents in electronic format to be able to be read through commonly available computer systems.

### 1.2 Rules of Construction

In the Constitution & Rules the following rules of construction apply:

- The masculine or feminine gender used in relation to any physical person shall, unless there is a specific provision to the contrary, be understood as including the other gender;
- As used herein, the words “may not”, “shall” and “will” are to be interpreted as a mandatory provision.
- In determining majorities, there will be always a rounding up to the nearest integer, e.g. the simple majority of 67 is 34, the two-third majority of 67 is 45 ( $67/3 \times 2 = 44.66$ , rounded up to 45).

## 2. SUMMARY OF CHANGES

Following the decisions of Congress in Leipzig the C&R Book has been updated. We have tried to improve the wording of many articles. Rule changes are highlighted by underlining the relevant passages. When articles have been deleted the old article is referred to. Bylaws approved by Council after the Ulsan Congress coming into effect up to the 1<sup>st</sup> April 2010 have been included in the rule book by partially underlining the relevant passages. These only will come definitively into effect if approved by the 2011 Congress.

1. For practical reasons the C&R Book has been divided into 5 Books.  
Some appendixes have been deleted, they will become part of the Organiser's Manual.  
Book 1 - Constitution - Administration (Chapters 1-6) (new appendixes 14 and 15)  
Book 2 - Outdoor Rounds (Chapter 7)  
Book 3 - Indoor Rounds (Chapter 8)  
Book 4 - Field Archery Rounds (Chapter 9)  
Book 5 - Ski-Archery Rounds (Chapter 10) - Miscellaneous Rounds (Chapter 11)

Articles changed – Approved by the Leipzig Congress in July 2007 (fully underlined):

2. Articles changed – Not yet approved by Congress (partially underlined). The articles changed are updated since 1 January 2010.  
The rules related to the change of the age for the Cadets and Juniors Classes is in effect since 1 January 2010.  
The new Compound Round will come into effect on 1 April 2011, but FITA and its Member Associations can organise events using this format prior to this date.  
However, World Records will be valid only as of 1 April 2011.
